# Privacy Policy

## Our Commitment to Your Privacy

We understand the high levels of commitment, human and financial resource allocations required to manage Food Safety and Quality Systems at the highest level. This is why we developed foodindustrycompliance.com as your knowledge, information, training and review tool for Food Safety and Quality Management!

foodindustrycompliance.com will not sell, trade, give or rent any personally or commercially identifiable information obtained from you to a third party without your consent. It is foodindustrycompliance.com's policy to allow Registered Users to provide as much, or as little personal or commercial information to us as they feel comfortable doing. You have complete control over the identifiable information foodindustrycompliance.com may collect. You have complete access to any information you have given us and to make any changes as required.

### The Information We Collect

When you visit foodindustrycompliance.com, you provide us with two types of information: personal and commercial information you knowingly choose to disclose that is collected by us, and web site use information collected by us as you interact with our web site. When you register with foodindustrycompliance.com, you provide us with certain business information such as business and contact details.

When you enter foodindustrycompliance.com, we collect your browser type and IP address. This information is gathered for all foodindustrycompliance.com visitors. In addition, we store certain information from your browser using "cookies". A cookie is a piece of data stored on the User's computer tied to information about the user. We use session ID cookies to confirm that users are logged in. These cookies terminate once the user closes the browser. At your request, we use a persistent cookie that stores your login ID (but not your password) to make it easier for you to login when you come back to foodindustrycompliance.com. You can remove or block this cookie using the settings in your browser if you want to disable this convenience feature.

You post Registered User content (as defined in the foodindustrycompliance.com [Terms and Conditions of Acceptable Use](#)) on the site at your own risk. Although we allow you to set privacy options that limit access to your pages, please be aware that no security measures are perfect or impenetrable.
